5	Obstructing access to switchboards, circuit breakers, switches, etc., of electrical equipment.	PLN 500
6	Using equipment, machinery, or tools that do not meet occupational health and safety (OHS) requirements, are damaged, incomplete, lack the required approvals, markings, attestations, certificates, inspections, or are used in a manner that may create a hazard.	PLN 1,000

13	Violation of segregation rules.	PLN 500 per incident found and the obligation to cover the costs of cleaning up and disposal of waste related to the clean-up
14	Activating the fire alarm.	PLN 2,000 and covering the costs of the Fire Brigade intervention
15	Carrying out dust-producing work without adequate protection.	PLN 1,000 per incident and suspension of work
16	Leaving the space in an untidy state after work is completed.	PLN 1,000 and the obligation to cover the costs of cleaning up
17	Failure to comply with the prohibitions and obligations set out in the regulations.	PLN 1,000 per incident
18	Infringement of exclusive rights.	20,000 per incident
