1. The Contractor is obliged to:
 - 1.1. Use collective and individual protective equipment.
 - 1.2. Use basic personal protective equipment, which includes:
 - protective helmet with a chin strap (for work at height) according to the *PN-EN 397+A1:2013-04* standard;
 - protective footwear of at least S1P class (with a protective toecap and an with anti-puncture insole) in accordance with the *PN-EN ISO 20345:2012* standard
 - high-visibility reflective waistcoat in accordance with the *EN ISO 20471:2013-07/A1:2017-02* standard (category 2) - the waistcoat should not be used for hot or fire hazardous work.
 - 1.3. Use personal protective equipment other than that listed under 1.2 if justified by the nature of the work to be performed - in accordance with *Table 2: Types of work where the use of personal protective equipment is required, as specified in Appendix 2 to the Regulation of the Minister of Labour and Social Policy of 26 September 1997 on general provisions for occupational health and safety (consolidated text: Journal of Laws of 2003, No. 169, item 1650, as amended)*.
 - 1.4. Use COVID-19 protective equipment, such as mouth and nose masks, disposable gloves or hand disinfectants in accordance with current legislation.
 - 1.5. Use only tools, materials and equipment in full working order, with the relevant attestations and technical approval certificates.
 - 1.6. Submit to the OHS Inspector of Międzynarodowe Targi Gdańskie SA:
 - 1.6.1. information on all occupational accidents and non-injury incidents occurring during the execution of works AMBEREXPO premises and a copy of the accident documentation drawn up in accordance with the regulations in force in this respect.
 - 1.6.2. information on all fire incidents (ignition, spontaneous combustion, fires and other local hazards) that occurred during the execution of works on the AMBEREXPO premises.
 - 1.7. Ensure the training of Contractors or their employees in occupational health and safety as well as fire protection before initiating work on the AMBEREXPO site. This training should take into account the specific nature of the tasks and the findings of the occupational risk assessment conducted.
 - 1.8. While conducting work on the AMBEREXPO premises, including particularly hazardous tasks, it is mandatory to possess up-to-date medical certificates confirming the absence of health contraindications for such work, along with valid occupational health and safety training certificate.
 - 1.9. Possess qualification appropriate to the type of work carried out.
 2. MTG reserves the right to carry out inspections with regard to compliance with applicable occupational health and safety, as well as fire protection regulations and rules.

3. One should follow the comments and instructions of the MTG representative.
 4. If, during the execution of works, a representative of MTG SA discovers non-compliance with the provisions outlined herein and identifies a significant breach of occupational health and safety or fire protection regulations as stipulated by generally binding provisions, MTG SA reserves the right to suspend work on the AMBEREXPO premises. The suspension of work must be communicated in writing, specifying the reason and justification for such suspension. Work may only be resumed once the underlying reason has been rectified, and the OHS Inspector of MTG SA has granted approval for the resumption of work. It is important to note that an appeal against a decision to suspend work does not exempt the involved parties from the obligation to cease work during the suspension period.
 5. In the case of documented inadequate execution of works, as indicated in the OHS inspection report and photo documentation, and involving non-compliance with OHS regulations or fire protection measures, Międzynarodowe Targi Gdańskie SA will impose a contractual penalty, the amount of which is specified in the table of penalties for each such instance.
 6. The penalty will be charged on the basis of a note issued by Międzynarodowe Targi Gdańskie SA.
